

Bautex BWA 22-10 Bautex Wall Anchor

Bautex Limited Warranty Statement

Bautex Systems, LLC ("Bautex") warrants to the person or entity ordering, purchasing or accepting delivery of these Bautex Wall Anchor BWA 22-10 ("Buyer"), that these Bautex Wall Anchors BWA 22-10 ("Anchors") are free from defects in workmanship and materials only at the time of shipment from our factory.

Buyer may only transfer and assign this warranty to an End User. "End User" means a final purchaser that (i) has acquired the Anchors for its own internal use and benefit; (ii) has not acquired the Anchors for resale, remarketing, distribution, or other use; and (iii) is the owner of one or a series of buildings, constructions or other structures where the Anchors are, have been, or will be used, incorporated or installed.

If any Anchors prove to contain manufacturing defects, Bautex will, at its option, either replace such Anchors (or the defective part) or credit or refund the purchase price of such Anchors at the pro rata contract rate, provided that, if Bautex so requests, Buyer shall return such Anchors to Bautex at Bautex's expense. This limited warranty is the only warranty extended by Bautex with respect to the Anchors. The dollar value of Bautex's liability and Buyer's remedy under this limited warranty shall not exceed the purchase price of the Anchors in question.

This warranty does not apply to any failure caused by or due to (i) workmanship in the installation of the Anchors, (ii) failure to follow Bautex's oral or written instructions as to the storage, installation, commissioning, use or maintenance of the Anchors, (iii) abuse of the Anchors, (iv) alterations or repairs made to the Anchors without the prior written consent of Bautex, (v) incompatibility with other materials, (vi) acts of God, or (vii) inadequate or faulty design of the subject structure.

In addition, this warranty does not cover any costs or expenses associated with (i) the removal of the Anchors, if already installed; (ii) the removal or replacement of any material including the exterior or interior facade in connection with the testing, repair, removal or replacement of the Anchors; (iii) the cost to ship the replacement Anchors; or (iv) damages or repairs of any kind or nature to the subject building, whether caused by removal or replacement of the Anchors or other material, or otherwise.

THE FOREGOING WARRANTY IS EXCLUSIVE AND IS IN LIEU OF ANY AND ALL OTHER GUARANTEES OR WARRANTIES. EXPRESS OR IMPLIED. INCLUDING WITHOUT LIMITATION ANY WARRANTY OF MERCHANT-ABILITY, WARRANTY OF PARTICULAR PURPOSE, WARRANTY OF TITLE, WARRANTY AGAINST IN-FRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS OF A THIRD PARTY, OR ANY WARRANTY IMPLIED BY COURSE OF PERFORMANCE, COURSE OF DEALING, USAGE OF TRADE, OR OTHERWISE. THE REMEDIES OF THE BUYER FOR ANY BREACH OF THIS WAR-RANTY SHALL BE LIMITED TO THOSE HEREIN PRO-VIDED TO THE EXCLUSION OF ANY AND ALL OTHER REMEDIES. BAUTEX SHALL NOT BE LIABLE IN ANY CASE FOR ANY DAMAGE TO THE BUILDING OR THE CONTENTS THEREOF, NOR WILL IT BE RESPONSIBLE FOR SPECIAL, INCIDENTAL, CONSEQUENTIAL OR PENAL DAMAGES. NO AGREEMENT VARYING OR EXTENDING THE FOREGOING WARRANTY REMEDIES WILL BE BINDING UPON BAUTEX UNLESS IN WRITING AND SIGNED BY A DULY AUTHORIZED OFFICER OF BAUTEX.

Bautex shall not be liable for a breach of this limited warranty unless (i) Buyer gives written notice of the defect, reasonably described, to the address below within ten (10) days after Buyer discovers or ought to have discovered the defect; (ii) Buyer provides Bautex with a reasonable opportunity after receiving notice to examine such Anchors, including (at the written request of Bautex) delivering such Anchors to Bautex's place of business in order for Bautex to examine them; and (iii) Bautex reasonably verifies Buyer's claim that the Anchors are defective. Bautex shall not be liable for a breach of this limited warranty if Buyer makes further use of the Anchors after giving notice of defect described above.Warranty claims should be sent to:
